- Whole Persons
- Unique and different
- Our own selves
- Capable of being mature
- Recognizing that our past still is a part of us
- Capable of recognizing red tape and barriers
- Going to be different in the future. We are the future.
- Capable and ready
- Have a bigger understanding of the whole world
- Acknowledging that the good and bad shapes us
- People who understand things like the economy and politics
- Acknowledging our struggles
- Entirely capable of happiness
- Our own story

Thank you for having this framework in order to get to know us.

You will find the Terms of Engagement we have all agreed to in serving, the Terms of Reference for the entire Table, and Meeting Minutes in this Report thanks to the staff of the Child & Youth Advocate Office. We hope this demonstrates the seriousness of the topics we are all willing to engage in to best help our community.

Lastly, we have included the one of the United Nation documents we researched to share with the Table: The Convention of the Rights of The Child. We hope this helps to further shape the topics we are willing and capable of addressing.
